Introduction

Zueitina Oil Company intends to issue the below Tenders and wish to invite experienced and reputable Contractor / Bidder specialized in similar type of works to execute these construction projects on the basis of EPC Contract.

Projects Titles:

- ASPHALT PAVEMENT RESURFACING AND REPAINT THE MARKINGS OF THE TWO AIRSTRIPS AT ZUEITINA TERMINAL.
- ASPHALT PAVEMENT RESURFACING OF THE APRON, TAXIWAY AND REPAINT THE MARKINGS OF THE AIRSTRIP AT 103A.

Brief Description of the Projects Scope of Work:

Zueitina Oil Company Operates a Coastal Oil and Gas products export facility on the Mediterranean Coast, approximately 180 Km south of the Libyan city of Benghazi.

The Company intends to resurface the asphalt pavement of the Runways at Zueitina Terminal and the Apron / Taxiway at 103A field. The works involve design, engineering, survey, procurement and supply of materials, inspection, testing, milling, resurfacing the runways, taxiways and aprons with asphalt pavement and the application of the runway Markings, in addition to other maintenance works.

The runway Markings; layout and application shall be to requirement of the International Civil Aviation Organization (ICAO) subject to approval of the Libyan Civil Aviation Authority (LCAA). The work shall also consists of providing detailed asphalt paving procedure, asphalt pavement mix design, asphalt repairs with procedure and application.

Interested Contractor to participate in the above Tenders shall fulfil the following qualification requirements for participating in the Tender.

Qualification Requirement for Participating In the Tender

Interested Companies intending to participate in the above tender must satisfy the specified requirements hereunder and submit the required information below. Failure to submit any of the under listed documents will render automatic disqualification.
